A RESOLUTION AUTHORIZING THE MAYOR OF THE CITY OF MOUNTAIN HOME TO ATTACH LIENTS TO CERTAIN PROPERTIES LOCATED AT THE ADDRESSES SPECIFIED IN THIS RESOLUTION FOR THE PURPOSE OF COLLECTING MONIES WHICH ARE OWED THE CITY OF MOUNTIAN HOME FOR ENFORCEMENT OF ORDINANCE NO. 2020-20.

WHEREAS, the City Council of Mountain Home, Arkansas approved Ordinance No. 2020-20 that states incorporated cities of the first class are empowered to order the owner of lots and other real property within the city limits to cut weeds, to remove garbage, rubbish and other unsightly and unsanitary articles and things upon the property.

WHEREAS, it shall be the duty and responsibility of the Code Enforcement Officer or his designee to determine the ownership and condition of any property suspected of being in violation. It shall be the duty of the Code Enforcement Officer or his designee to certify the ownership and condition of any parcel of land he determines to be in violation to the mayor of the city.

AN ORDINANCE AMENDING ORDINANCE NO. 96-033 AND ALL PREVIOUS AMENDMENTS THERETO; AMENDING THE CLASSIFICATION AND COMPENSATION PLAN INCLUDING THE GRADE AND STEP SCALE FOR THE MOUNTAIN HOME STREET DEPARTMENT; DECLARING AN EMERGENCY AND FOR OTHER PURPOSES
WHEREAS, the City of Mountain Home, AR previously adopted a Job Classification and Compensation Plan; and
WHEREAS, the City of Mountain Home Street Department desires to amend the plan as it relates to the street department;
NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOUNTAIN HOME, ARKANSAS:
Section 1: The Job Classification and Compensation Plan for the City of Mountain Home, Arkansas Street Department shall be and is hereby amended as reflected in Exhibit "A" which is attached hereto. Exhibit "A" reflects the Crew Positions - Step & Grade for the Street Department and the positions and grades noted therein shall be effective from and after the passage of this Ordinance.
Section 2: All other provisions of Ordinance No. 96-033, and all amendments thereto, shall remain in full force and effect, unless specifically amended by the terms and conditions of this Ordinance.
Section 3: The prompt and efficient completion of street projects within the City of Mountain Home, AR benefit the health and safety of its citizens and therefore this Ordinance shall be in full force and effect from and after its passage.

# AN ORDINANCE WAIVING COMPETITIVE BIDDING AND AUTHORIZING THE PURCHASE OF A DODGE TRUCK

WHEREAS, the City of Mountain Home Street and Water and Sewer Departments is desirous of purchasing six (6) one-ton Trucks and seven (7) half-ton Dodge Trucks.

WHEREAS, the Dodge trucks are necessary to meet the needs of the Street, Water, and Sewer Departments.

## NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF MOUNTAIN HOME, ARKANSAS

SECTION 1. The Street, Water and Sewer Departments of the City of Mountain Home, Arkansas desires to purchase six one-ton Dodge Trucks and seven half-ton Dodge Trucks for the purpose of replacing existing older vehicles.

SECTION 2. Due to the nature of the purchase and the amount of the purchase the Street, Water, and Sewer Departments would like to purchase locally, as the Street, Water and Sewer departments usually uses state bid to purchase with. Ultimate Auto Group has offered their pricing at or below the state bid price.

SECTION 3. That the Street, Water, and Sewer Departments is hereby authorized to purchase six one-ton Dodge Trucks for a sum not to exceed \$360,000 (Three Hundred Sixty Thousand Dollars) and seven half-ton Dodge Trucks for a sum not to exceed \$350,000 (Three Hundred Fifty Thousand Dollars) from Ultimate Auto Group, Mountain Home, AR.

WHEREAS, the purchase of the thirteen Trucks is necessary for Street, Water, and Sewer Departments. An emergency is therefore declared to exist; and this Ordinance shall be in full force and effect from and after its passage.



ORDINANCE NO.
AN ORDINANCE AMENDING SECTION 5 EXISTING SIGNS OF THE MOUNTAIN HOME SIGN ORDINANCE NO 2019-34
WHEREAS, the purpose of this Ordinance is to promote the reasonable, orderly, and effective display of signs while remaining consistent with the City policy to protect the public investment in the streets and highways, to promote the safety and recreational value of the public and to preserve natural beauty of the City of Mountain Home.
WHEREAS, new modern designs blend in to the surrounding landscaping better, are safer and less distracting than older designs.
NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MOUNTAIN HOME ARKANSAS:
Section 5 of the Mountain Home Sign Ordinance NO. 2019-34 shall be amended to read as follows: #5. Existing Billboards or Outdoor Advertising Structures within the City of Mountain Home that are still installed with wood structures as the main support shall be allowed to change to a single engineered mono pole, provided the height, sign face square footage and number of sign faces stay the same as the existing sign. Stamped engineered drawings shall be submitted to the City for approval before any changes are made to said signs.
