## REGULAR CITY COUNCIL MEETING – December 16<sup>th</sup> , 2021

1. The Mountain Home City Council met in regular session December 16<sup>th</sup>, 2021 in the Council Chambers of the Municipal Building. Mayor Hillrey Adams called the meeting to order at 6:00 p.m. followed by the Pledge of Allegiance and a prayer.
2. **ROLL CALL** The following council members were present for the roll call: Nick Reed, Jim Bodenhamer, Paige Evans, Jeinnifer Baker, Susan Stockton, Carry Manual, Robert Van Haaren and Wayne Almond were present for the meeting.
3. **OFFICIALS IN ATTENDANCE** Mayor Hillrey Adams, City Clerk Brian Plumlee, City Attorney Roger Morgan, Police Chief Eddie Griffin, Fire Chief Khris Quick, Human Resources Sue Edwards and Building Inspector Greg Ifland.
4. **PRESS** Scott Liles of the Baxter Bulletin and Chris Fulton from the Mountain Home Observer.
5. **MINUTES** Councilman Baker made a motion to approve the council meeting minutes from November 18<sup>th</sup>, 2021 and from December 2<sup>nd</sup>, 2021. The motion was seconded by Councilwoman Stockton. The City Clerk recorded the following vote: 7 – yes ; Reed, Bodenhamer, Evans, Baker, Almond, Stockton, and Manual ; 1 – abstain : Van Haaren.
6. **NEW BUSINESS**

**CPI REQUEST FROM METHVIN SANITATION** City Attorney Roger Morgan explained that the CPI is locked into the contract. A 4.8 % increase will take effect beginning January 1, 2022. Councilwoman Baker made a motion to approve the request, Councilman Carry Manuel seconded the motion. The City Clerk recorded the following vote: all present – yes.

**AN ORDINANCE VACATING UTILITY EASEMENTS LOCATED BETWEEN LOTS 94 AND 95 OF BIG CREEK ESTATES, PHASE 1 WITHIN THE CITY LIMITS OF MOUNTAIN HOME, ARKANSAS.** *A scheduled public hearing took place shortly before the council meeting started regarding the lots listed above, Mayor Adams asked if there was any public input, there was none.* City Attorney Roger Morgan put the ordinance on first reading and read it to its entirety.
