PUBLIC HEARING ON 2025 WATER-SEWER MPROVEMENT BONDS – Thursday, April 17th, 2025

- 1. The City of Mountain Home and the Mountain Home City Council hosted a public hearing on May 17, 2025, in the Council Chambers of the Municipal Building.
- <u>CITY OFFICIALS IN ATTENDANCE</u> Mayor Hillrey Adams; City Clerk Scott Liles; City Attorney Roger Morgan; Public Works Director Steve Hill; Police Chief Eddie Griffin; and Parks Director Daniel Baxley. Council members in attendance included Susan Stockton, Jennifer Baker, Wayne Almond, Philip Frame, Carry Manuel, Jim Bodenhamer and Nick Reed.
- **3.** <u>OTHERS IN ATTENDANCE</u> Paul Phillips with Crews & Associates (bond underwriter), and Gordon Wilbourn with Kutak Rock LLP (bond attorneys). Caroline Spears of the Baxter Bulletin. Three members of the public.
- 4. <u>CALL TO ORDER</u> According to the legal notice announcing the hearing, it was scheduled to begin at 4:45 p.m. Mayor Hillrey Adams called the hearing to order at 4:51 p.m., with a total of 19 people in attendance.
- 5. <u>OPEN FLOOR</u> Once convened, Mayor Hillrey Adams asked for questions or comments from the floor on the proposed bond ordinance. No comments were given, nor any questions raised.
- 6. <u>ADJOURNMENT</u> With no further questions or comments being offered from the public, Mayor Hillrey Adams declared the public hearing concluded at 4:53 p.m.

MINUTES REGULAR CITY COUNCIL MEETING – Thursday, April 17th, 2025

- The Mountain Home City Council met in regular session on April 17, 2025, in the Council Chambers of the Municipal Building. Mayor Hillrey Adams called the meeting to order at 5 p.m.
- 2. <u>CITY OFFICIALS IN ATTENDANCE</u> Mayor Hillrey Adams; City Clerk Scott Liles; City Attorney Roger Morgan; Human Resources Director Sue Edwards Strop; Public Works Director Steve Hill; Police Chief Eddie Griffin; Fire Chief Kris Quick; Parks Director Daniel Baxley
- **3.** <u>MEDIA IN ATTENDANCE</u> Caroline Spears of the Baxter Bulletin. The meeting was also streamed on Facebook by XL7 TV.
- 4. <u>ROLL CALL</u> Following the Pledge of Allegiance and an invocation, the following Council members were present for the roll call: Susan Stockton, Jennifer Baker, Wayne Almond, Philip Frame, Carry Manuel, Jim Bodenhamer and Nick Reed. Council member Bob Van Haaren was absent.
- 5. <u>APPROVAL OF THE APRIL 3RD MINUTES</u> Council member Jennifer Baker made a motion to approve the minutes from the Council's April 3rd meeting. The motion was seconded by Council member Wayne Almond. *The vote was recorded as follows: Yes All present.* Absent Bob Van Haaren. The motion carried, and the April 3rd minutes were adopted.

6. <u>NEW BUSINESS</u>

AN ORDINANCE AUTHORIZING THE ISSUANCE AND SALE OF NOT TO EXCEED \$10,000,000 OF WATER AND SEWER REVENUE IMPROVEMENT BONDS, SERIES 2025, BY THE CITY OF MOUNTAIN HOME, ARKANSAS FOR THE PURPOSE OF FINANCING THE UPGRADING, MODERNIZATION AND IMPROVEMENT OF THE CITY'S WASTEWATER TREATMENT PLANT; AUTHORIZING THE EXECUTION AND DELIVERY OF A SIXTH SUPPLEMENTAL TRUST INDENTURE PURSUANT TO WHICH THE BONDS WILL BE ISSUED AND SECURED; AUTHORIZING THE EXECUTION AND DELIVERY OF A BOND PURCHASE AGREEMENT PROVIDING FOR THE SALE OF THE BONDS; AUTHORIZING THE EXECUTION AND DELIVERY OF AN OFFICIAL STATEMENT PURSUANT TO WHICH THE BONDS WILL BE OFFERED; AUTHORIZING THE EXECUTION AND DELIVERY OF A CONTINUING DISCLOSURE AGREEMENT PROVIDING FOR THE ONGOING DISCLOSURE OF CERTAIN INFORMATION REGARDING THE CITY AND THE SYSTEM; PRESCRIBING OTHER MATTERS **RELATING THERETO; AND DECLARING AN EMERGENCY** If adopted, this Ordinance would authorize the sale of \$10 million in 2025 Water-Sewer Improvement Bonds. Revenue from the bonds would be used to complete renovations to the City's wastewater treatment plant. In 2021, the City issued \$10 million in Water-Sewer bonds to begin the project, and this new set of bonds would finance the second half of those renovations. Improvements to the wastewater plant would include replacing the existing chlorination process with a

safer ultraviolet light process, upgrades to the existing electrical structure and installation of a system-wide SCADA master control system.

SUSPEND THE RULES, READ BY TITLE ONLY Council member Phillip Frame made a motion to suspend the rules and read the proposed Ordinance by title only in its first read. His motion was seconded by Council member Jim Bodenhamer. *The vote was recorded as follows: Yes – All present, Absent – Bob Van Haaren. The motion carried and City Attorney Roger Morgan read the Ordinance by title only on its first reading.*

SECOND READING After the item's first reading, Council member Jennifer Baker made a motion to suspend the rules and place the item on its second reading by title only. That motion was seconded by Council member Nick Reed. *The vote was recorded as follows:* Yes – All present, Absent – Bob Van Haaren. The motion carried and the proposed Ordinance was read a second time.

THIRD READING Following the second reading, Council member Jennifer Baker made a motion to suspend the rules and place the item on its third reading by title only and drew a second from Council member Nick Reed. *The vote was recorded as follows: Yes – All present, Absent – Bob Van Haaren. The motion carried and the proposed Ordinance was read a third time.*

ADOPTION Following the item's third reading, Council member Jennifer Baker made a motion to adopt the proposed Ordinance and was seconded by Council member Nick Reed. *The vote was recorded as follows: Yes – All present, Absent – Bob Van Haaren. The Ordinance was declared adopted and numbered Ordinance No. 2025-15.*

EMERGENCY CLAUSE Following the adoption of Ordinance No. 2025-15, Council member Jennifer Baker made a motion to attach the City's Emergency Clause to the item so that it immediately went into effect. That motion was seconded by Council member Nick Reed. *The vote was recorded as follows: Yes – All present, Absent – Bob Van Haaren. The motion carried and the Emergency Clause was adopted for Ordinance No. 2025-15.*

CITY CLERK'S NOTE Revenue from the sale of the 2025 Water-Sewer bonds is anticipated to become available in late May. The City anticipates completing the renovations on the wastewater treatment plant in the second quarter of 2026.

AN ORDINANCE ACCEPTING THE FINAL REPLAT AND PUBLIC DEDICATIONS FOR LOT 2, WEST END PHASE 1, LOCATED AT WEST END WAY IN MOUNTAIN HOME, ARKANSAS; AND FOR ACCEPTING IMPROVEMENTS THEREWITH If adopted, this Ordinance would accept the final replat and public dedications for Lot 2 of the West End commercial development. The proposed replat was approved by the Planning Commission on April 14 and would split the two existing lots on the premises into five smaller lots for commercial development. City Attorney Roger Morgan placed the proposed Ordinance on its first read in its entirety. **SECOND READING** After the item's first reading, Council member Philip Frame made a motion to suspend the rules and place the item on its second reading by title only. That motion was seconded by Council member Susan Stockton. *The vote was recorded as follows: Yes – All present, Absent – Bob Van Haaren. The motion carried and the proposed Ordinance was read a second time.*

THIRD READING Following the second reading, Council member Jennifer Baker made a motion to suspend the rules and place the item on its third reading by title only and drew a second from Council member Susan Stockton. *The vote was recorded as follows: Yes – All present, Absent – Bob Van Haaren. The motion carried and the Emergency Clause was adopted for Ordinance No. 2025-16.*

REQUEST TO SELL THE FOLLOWING ITEM AND REMOVE IT FROM THE INVENTORY OF THE MOUNTAIN HOME FIRE DEPARTMENT: MOBILE SMOKE HOUSE FOR CHILDREN'S EDUCATION (VIN# 0316SM019W8290228) Fire Chief Kris Quick asked for the Council's permission to sell a surplus mobile smoke house the Fire Department used to use in its children's education and outreach programs. This unit is built out of a 1998 camper frame and is no longer used by the City since it purchased an inflatable smoke house that can be used indoors (like inside a gymnasium). By comparison, the camper-based smoke house requires students to go out to the parking lot to go through the demonstration, meaning that the Fire Department cannot use it when it's extremely cold or raining. Quick said he hoped to sell the camper by sealed bid should the Council approve his request.

Council member Jim Bodenhamer made a motion to grant the Fire Department permission to sell the smoke house, and was seconded by Council member Susan Stockton. The vote was recorded as follows: Yes – All present, Absent – Bob Van Haaren. The motion carried and the Fire Department was given permission to sell the smoke house.

AN ORDINANCE AMENDING ORDINANCE NO. 2022-21, 2022-32, 2022-45, 2022-49, 2023-18, 2023-34, 2024-15 AND 2025-8 TO EXPAND AND REDEFINE THE JOB CLASSIFICATION AND COMPENSATION PLAN IN ORDER TO ENHANCE EFFICIENT MANAGEMENT WITHIN THE DEPARTMENTS OF THE CITY OF MOUNTAIN HOME, ARKANSAS If approved, this Ordinance would add the position of Public Works executive

assistant to the City's job classifications as a Grade 17 position. This assistant would work for both the Street Department and the Water/Sewer Department and assist Public Works Director Steve Hill with paperwork, office management and other tasks. The proposed Ordinance would also delete the job classifications of chief deputy treasurer and chief deputy court clerk (both Grade 17 positions), as those titles are no longer used. City Attorney Roger Morgan placed the proposed item on its first reading in its entirety.

SECOND READING After the item's first reading, Council member Jennifer Baker made a motion to suspend the rules and place the item on its second reading by title only. That motion was seconded by Council member Nick Reed. *The vote was recorded as follows:* Yes – All present, Absent – Bob Van Haaren. The motion carried and the proposed Ordinance was read a second time.

THIRD READING Following the second reading, Council member Jennifer Baker made a motion to suspend the rules and place the item on its third reading by title only and drew a second from Council member Carry Manuel. *The vote was recorded as follows: Yes – All present, Absent – Bob Van Haaren. ADOPTION Following the item's third reading, Council member Jennifer Baker made a motion to adopt the proposed Ordinance and was seconded by Council member Carry Manuel. *The vote was recorded as follows: Yes – All present, Absent – Bob Van Haaren. The Ordinance was declared adopted and numbered Ordinance No. 2025-17.*

EMERGENCY CLAUSE Following the adoption of Ordinance No. 2025-17, Council member Jennifer Baker made a motion to attach the City's Emergency Clause to the item so that it immediately went into effect. That motion was seconded by Council member Wayne Almond. The vote was recorded as follows: Yes – All present, Absent – Bob Van Haaren. The motion carried and the Emergency Clause was adopted for Ordinance No. 2025-17.

PROPOSAL FROM THE NORTH CENTRAL ARKANSAS ECONOMIC ALLIANCE (NCAEA) REGARDING ECONOMIC DEVELOPMENT FUNDING North Central Arkansas Economic Alliance representatives Allen Moore and Jim Brown addressed the Council on behalf of the NCAEA. The organization is hoping to renew it's yearly economic development contract with the City of Mountain Home. The agreement, which is like the agreement signed last year, would pay the NCAEA \$10,000 per quarter for economic development services. Last year's agreement was in place for three-quarters of the year, and the City paid the Alliance \$30,000.

Moore noted that the City was currently witnessing economic development with the planned commercial developments in the West End and a McAlister's Deli soon to open here in town. Continuing to invest in the NCAEA's efforts would continue to help propel the area forward, he said. Brown noted that the City's funding for the Alliance has been vital for several recent projects. Last year, the NCAEA hosted the Arkansas Department of

Transportation commissioners for a visit to the Twin Lakes Area, and earlier this year cohosted a legislative reception in Little Rock to connect with capitol lawmakers. The Alliance also helped sponsor the Arkansas Draft Day, where 500 area students got the opportunity to sit for job interviews with area employers.

Council member Jim Bodenhamer asked for clarification on the Alliance's relationship with the Mountain Home Area Chamber of Commerce, noting that Chamber President/CEO Dani Pugsley is listed as the NCAEA's president/CEO. The Alliance is a standalone entity separate from the Chamber, Jim Brown said. "We are not the Chamber, and the Chamber is not us," he told the Council. Brown said Pugsley holds the dual positions of Chamber president/CEO and Alliance president/CEO because when a business is interested in relocating to Mountain Home, they will often contact the Chamber for information, and Pugsley could then help in either capacity. Pugsley is also in charge of keeping track of the paperwork generated by the Alliance, something that private business owners do not have the time or inclination to do, he noted.

City Attorney Roger Morgan noted that such economic development contracts are required to be adopted by ordinance or resolution. The Alliance's contract/a resolution approving the contract will return at the Council's May 1 meeting for consideration.

Area resident Mary O'Shields told the Council she was in favor of continuing the City's contract with the Alliance.

CITY CLERK'S NOTE At this point in the meeting, Mary O'Shields accidentally turned off the podium microphone while adjusting it before making her comments. As such, there is no audible recording of her comments on the XL7 TV broadcast or the audio recording maintained by the City Clerk. Likewise, the motion to adjourn was not audibly recorded.

7. ADJOURNMENT

With no further business to come before the council, Council member Susan Stockton made a motion to adjourn the meeting and drew a second from Council member Waye Almond. A voice vote was recorded as follows: Yes – All present, Absent – Bob Van Haaren. Mayor Hillrey Adams then declared the meeting adjourned at 5:38 p.m.

POLICE/FIRE REPORTS Fire Chief Kris Quick and Police Chief Eddie Griffin delivered their monthly reports and figures to the Committee.

1. Fire Department Monthly Performance

The performance this month is significantly better than last month, with a 50 to 60 increase compared to the same time last year. The team is actively working on fire hydrants, and a new Dodge Durango has been received.

2. Reporting System Change

The organization is switching to a new reporting system, completely leaving the previous group. Details about the new system were not disclosed.

3. Smokehouse Replacement

A proposal will be taken to the council to dispose of the old camper trailer smokehouse, which hasn't been used in two years, in favor of an inflatable smokehouse that works better.

4. Siren System Evaluation

The county is evaluating their siren system, and there is a discussion about replacing it. The city might be involved, but it would be at their expense. The cost of a new system is between 30,000 to 33,000.

5. New Police Department Building

The new police department building is expected to be ready for moving in on April 27th and 28th. The interior and exterior improvements are progressing well.



6. Police Cars and Staffing

Three new police cars are in transit, and the department is interviewing for two open positions. A new background check process is being implemented.

7. Canine Program Expansion

A new canine will be added to the program, funded by a donation. The new dog will focus on drugs and tracking, similar to the current canine.

8. Animal Control Operations

Animal control operations are primarily Monday through Friday, with weekend coverage available if needed. Discussions are ongoing to improve kennel space availability.







RESOLUTION NO. 2025-xx A RESOLUTION AUTHORIZING THE CITY OF MOUNTAIN HOME TO ENTER INTO AN ECONOMIC DEVELOPMENT CONTRACT

WHEREAS, the City of Mountain Home declared Economic Development Services to be an "other Professional Service" by Resolution No. 2024-6;

WHEREAS, professional service procurement procedures have been followed in the procurement of economic development services; and

WHEREAS, the City desires to enter into an Economic Development Agreement with North Central Arkansas Chamber Foundation, DBA North Central Arkansas Economic Alliance, for the purpose of providing economic development services.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MOUNTAIN HOME, ARKANSAS

1) That the City of Mountain Home, AR, approves the Economic Development Agreement with the North Central Arkansas Chamber Foundation. A copy of which is attached hereto as "Exhibit A."

2) That the Mayor and City Clerk are authorized to execute the agreement on behalf of the City of Mountain Home, AR.

3) Funds for the Economic Development Agreement shall be sourced from revenue derived from the City's business license fees.

ECONOMIC DEVELOPMENT AGREEMENT

This Agreement is made and entered into this <u>01</u> day of <u>May</u>, 20<u>25</u>, by and between the City of Mountain Home, Arkansas (hereinafter "the City"), and the North Central Arkansas Chamber Foundation DBA the North Central Arkansas Economic Alliance (hereinafter "the Alliance") for the period January 1 through December 31,2025.

RECITALS

- A. The City and the Alliance understand the necessity of ensuring and maintaining a vibrant, healthy, and effective business and economic development environment.
- B. The City requires the professional services of the Alliance to develop, promote, and implement policies and strategies to give the maximum possible support and assistance to local and established businesses.
- C. It is essential to the public health, safety, and economic welfare of the citizens of Mountain Home, Arkansas, that the City retains the Alliance to provide its citizens and businesses with these professional services.
- D. The Alliance is in a unique situation and uniquely qualified to provide professional, regional economic development services to the City. Also, the City and Alliance have determined that the Alliance and its Board of Directors have the experience and ability to provide the additional regional services of acquisition and development of industrial, commercial, and business properties and facilities to house or otherwise provide for the needs of industry, commerce, business to promote industrial, commercial, and business expansion.
- E. Both parties recognize that the economic development of the region and the promoting of and assisting the growth and development of business concerns, including retail, commercial, and industrial concerns, will increase employment and improve the region.
- F. The City desires to contract with the Alliance to provide industrial development and marketing services, as defined in Ark. Code Ann. 14-176-103.
- G. Pursuant to Arkansas law, it is necessary that a valid and enforceable contract for professional services be executed by and between the City and the Alliance; this Agreement clearly enumerates the professional services to be conducted by the Alliance for the benefit of the City; that it be clear from the terms of the Agreement that the City or the Alliance are taking no action that could be determined, or interpreted, as the City merely making a gift of said monies to the Alliance.
- H. Under the terms of this Agreement, it is clear that the City shall receive unique, specialized, and tangible benefits in the form of professional services rendered by the Alliance, which would not be received by the City without the benefit of this Agreement.
- I. To accomplish the foregoing, the parties desire to enter into this Agreement, which shall authorize the Alliance to assist the City with local economic development in the county and surrounding area and to assist in the acquisition and development of industrial parks and facilities to house or otherwise provide for industrial, commercial, business and economic expansion.

NOW, THEREFORE, IN CONSIDERATION OF THE SUBSTANTIAL AND DIRECT ECONOMIC BENEFITS AND THE MUTUAL PROMISES OF THE SUPPORT AND COOPERATION TO BE DERIVED HEREUNDER, THE PARTIES AGREE:

SECTION 1:

- A. The term of this Agreement shall be one year, from January 1 through December 31,2025
- B. The City agrees to pay the Alliance Forty Thousand Dollars (\$40,000) for the period of the Agreement term, to be paid in quarterly payments, subject to the contingency hereinafter provided.
- C. The Alliance shall utilize such funds for the general economic development of the area, which includes, but is not limited to, industrial and business recruitment and location, improvement, and expansion of industry currently located in or near the City, general improvement of business and economic conditions in the affected area, improvement, and expansion of transportation and utility resources, development of legislative and gubernatorial relationships and contacts and all other functions that may be related to the expansion and development of the economy in or near the City.

SECTION 2: The Alliance shall provide the following services for the term of the Agreement:

A. The Alliance shall establish and maintain personnel or engage professional services which:

(1) Utilize a knowledgeable, professional or professional staff with demonstrated expertise in the field of economic development that shall work at the request of the Alliance within the scope and services as defined in this Agreement;

(2) Provide and maintain an office for economic and industrial development;

(3) Engage such other professionals and agreements for such other services as the Alliance, in its discretion, shall deem desirable to effectuate the City's economic development program upon approval from the City if paid by public funds;

(4) In all other respects, provide the City with professional economic and industrial development management expertise as defined in Ark. Code Ann. 14-176-103.

B. Serve as a primary point of contact for economic development services for the City by functioning as a contact and liaison with organizations throughout the State of Arkansas and beyond, whose mission is the attraction or retention of commercial companies or industries to coordinate and promote the following:

(1) Working with the Arkansas Economic Development Commission (AEDC), the International Economic Development Council (IEDC), Main Street Arkansas, Arkansas State Alliance of Commerce/AIA, Arkansas Economic Development & Alliance Executives (AEDCE), Arkansas State University-Mountain Home (ASUMH), and numerous other private or public agencies related to Economic Development on behalf of the City and region and provide updates and information on economic development and available grants, loans, funds, tax credits and other incentives from these types of programs and agencies;

(2) Establishing and maintaining a working relationship with local utilities, State Representatives, and Senators, Arkansas' Congressional delegation, the AEDC, IEDC, State Alliance, AEDCE, and various other agencies and programs;

(3) Establishing and maintaining relationships with commercial real estate brokers;

(4) Seeking, discovering, and endeavoring to attract new and expanding retail, commercial businesses, and industries within the City and region to create jobs and investment for the benefit and economic development and improvement of the residents of the City;

(5) Identify industries and commercial businesses in the region that are eligible for local sales and use tax refunds and other incentives under the Jobs Creation by Stimulating Small Business Growth Act of 1985, Arkansas Economic Development Act of 1993, Arkansas Enterprise Zone Act of 1993, Major Industry Facilities Act, Arkansas Economic Development Act of 1995, Arkansas Workforce Investment Act, Arkansas Public Roads Improvements Credit Act, Nonprofit Incentive Act of 2005, Arkansas Amendment 82 Implementation Act, Biodiesel Incentive Act, Equity Investment Incentive Act of 2007, Incentives for Major Maintenance and Improvements Projects Act, New Market Jobs Act of 2013, Economic Investment Tax Credit Act and Consolidated Incentive Act of 2003 and provide the City with necessary business information for it to pass a resolution endorsing the applicant businesses' or industry's participation in the AEDC's sales and use tax refund program.

C. Identify available industrial properties to be marketed to business, industrial, or other economic development prospects by:

(1) Actively marketing available industrial properties to prospective industries and consultants;

- (2) Conducting site visits with potential industry recruits;
- (3) Maintaining and establishing relationships with site selection consultants;
- (4) Assist with the preparing and handling all scheduling of meetings and site visits;

(5) Establishing and maintaining a list of available properties and sites for business growth and development and industrial use;

- (6) Identify available land for future industrial purposes;
- (7) Identify and stay aware of available industrial buildings for future industrial purposes;

(8) Staying up to date with available incentives, rules, regulations, and policies affecting or impacting business or industrial attraction.

(9) Incorporate data for the City of Mountain Home region on the Alliance website and other marketing materials, including brochures, emails, mailing, etc.;

D. Maintain demographic information of the City and surrounding area with the information compiled to a Alliance database:

(1) Make the general database information file available to potential employers;

(2) Continually assess, identify, and develop properties for future growth and development of the City,

(3) Develop, produce, print, publish, and deliver specialized economic development marketing materials that market the Mountain Home area and maintain updated information within those materials;

(4) Create and maintain an attractive website that caters to existing and prospective businesses and industries;

(5) Develop, produce, print, publish, and deliver information packets to target commercial businesses and industries looking to expand or establish operations and maintain updated information within those packets as necessary.

SECTION 3: This Agreement does not evidence a partnership or joint venture between the Alliance and the City. The Alliance is an independent contractor to the City in connection with this Agreement. The officers and employees of the Alliance involved in the program of this Agreement shall not be considered for any purpose to be the officers of the City. The Alliance shall have no authority to bind the City absent the City's written

consent. Except to the extent otherwise provided in this Agreement, the Alliance shall bear its own costs and expenses in pursuit thereof.

SECTION 4: It is agreed that the President/CEO of the Alliance will be only employed by and responsible to the Alliance.

SECTION 5:

- (A) The Alliance will present a quarterly verbal and written report to the City regarding its economic development activities and other information requested by the City.
- (B) The Alliance shall account for all expenditures of public funds with proper receipts and records, which shall be submitted to the City for examination at any time upon request by the Mayor or Chair of the Mountain Home City Council Finance Committee.
- (C) No funds paid by the City shall be used directly or indirectly for lobbying, political activity, car allowances, country club memberships and dues, sporting events and activities, and non-directly related business traveling expenses.

SECTION 6: The Alliance shall not discriminate against any employee or person served under this Agreement based on race, color, sex, age, religion, ancestry, national origin, disability, or marital status or as otherwise prohibited by applicable law.

SECTION 7: The Alliance represents that it shall, as its sole cost and expense, comply with all applicable municipal, county, city, state, and federal requirements now in force pertaining to any and all activities contemplated under this Agreement, including any legal limitation placed upon the Alliance as a result of the source of funds received by the Alliance under this Agreement.

SECTION 8: The Alliance represents and warrants that it has not paid or agreed to pay any compensation, contingent or otherwise, direct or indirect, to solicit or procure this Agreement or any rights or benefits hereunder.

SECTION 9: The Alliance will remain an Arkansas non-profit corporation answerable to its Board of Directors and shall not be, or construed to be, a part of the City, but only to provide services on behalf of the City as listed in this Agreement.

SECTION 10: Any requests by the City to pursue a specific economic development goal using public funds shall not preclude the Alliance from pursuing other economic development goals decided by its Board of Directors when using private funding from private contributions.

SECTION 11: The provisions of this Agreement are severable. The invalidity or the unenforceability of any one provision in this Agreement shall not affect the other provisions.

SECTION 12: Nothing in this Agreement, express or implied, is intended to confer upon any person, other than the parties hereto and their respective successors and assigns, any rights or remedies under or by reason of this Agreement and, in particular, no employee, vendor, supplier, or other person contracting with the Alliance shall have any right by virtue of this Agreement or otherwise to seek payment or compensation from the City for goods delivered or services rendered to the Alliance.
