JOB DESCRIPTION: As a trainee, performs the routine operations of a wastewater treatment plant operator on an assigned shift.

ESSENTIAL JOB DUTIES AND RESPONSIBILITIES:

- 1) Learns and Makes regular inspections of plant and equipment to ascertain that it is in proper operation at all times.
- 2) Learns to collect samples and run operational test on wastewater.
- Washes down plant equipment and basins as needed.
- 4) Sweeps clarifiers and cleans skimmer as needed.
- Assists in general housekeeping chores.
- Cleans digestors to remove heavy sludge deposits.
- 7) Learns and performs routine custodial and grounds duties
- 8) Learns and Performs related duties as assigned

SPECIFIC KNOWLEDGE, SKILLS, ABILITIES, OR EDUCATION:

1) Ability to understand and follow oral and written instruction

- 2) Ability to keep records and make reports
- 3) Ability to learn basic laboratory techniques and procedures

IMMEDIATE SUPERVISOR: The plant supervisor assigns work in terms of general instructions. An employee in this class is responsible for efficient and safe plant operation and maintenance of plant equipment on an assigned shift as a trainee. Incumbents are expected to work towards higher level certifications so they may work independently and without constant supervision. The work is performed under the supervision of a higher level plant operator.

<u>PHYSICAL DEMANDS</u>: The physical demands described herein are representative of those that must be met by an employee to successfully perform the essential functions of this job. While performing the functions of this job, the employee is regularly required to talk or hear.

<u>WORK ENVIRONMENT</u>: The work environment characteristics described herein are representative of those an employee encounters while performing the essential functions of this job. <u>WORKING CONDITIONS</u>: Work is primarily performed outside and occasionally in laboratory, in inclement, hot/cold weather. The job is typically performed intermittently with climbing, sitting, standing, and walking. The employee occasionally lifts light to moderate and heavy objects and must use tools and equipment requiring manual dexterity and working from heights.

- 1) Ability to read, write and perform basic mathematical calculations at a level commonly associated with the completion of high school or its equivalent.
- 2) Sufficient experience to understand the basic principles relevant to the major duties of the position,
- 3) Position must obtain a Wastewater Treatment Plant Operator's license issued by ADEQ within 6 months of the first exam taken.
